Scope of Work- Snow Removal

Snow and ice accumulations will be cleared from all concrete walkways and steps as needed, and sidewalk safe ice melter will be applied on said areas in conjunction to, or separate thereof, snow removal. Corner parking lot and sidewalks will be cleared of snow and ice accumulations with every 1" of snowfall, concrete safe ice melter will be applied to concrete surfaces, and rock salt to blacktop, in conjunction to, or separate thereof; snow removal. Areas will be cleared for operational hours Monday thru Friday. Any snow accumulations after 5:00 p.m. on Friday will be cleared prior to opening on Monday morning. All labor, equipment and material will be supplied by the contractor.

Sidewalks will be cleared as needed. Areas will be cleared for operational hours 24 hour/7 day a week status, as needed. All labor, equipment and material will be supplied by contractor.
